

## PYSL 2021 FALL SEASON REFUND & PARENT AGREEMENT

Palmdale Youth Soccer League is dedicated to promoting sportsmanship through soccer to the youth of the Antelope Valley. We are a 100% volunteer organization and to avoid any misunderstandings here are some guidelines.

- Payment of fees does not guarantee your child will be placed on a team. All players are considered on a
  first come first paid basis. Decisions on team sizes and numbers of teams are based upon number of
  volunteer and what best suits the needs of the majority of the league members. Refund policy is shown below
  and applies only if your child is placed on a team. If necessary, division may be combined (co-ed divisions or
  two ages groups).
- 2. If your payment is not valid for any reason, your child's registration will be placed on hold until all funds (including any returned fees) become available. The date the fee is paid in full, is the registration date of your player(s).
- 3. Your fees include registration, uniform, basic picture package and trophy. Trophies are distributed on the last game of the season to the coaches or team parents.
- 4. Please carefully mark all uniform sizes on the registration form. Sizes you mark are sizes we order, any mistakes you make will be reordered at cost and charged to you.

## No refunds will be processed without a valid receipt, no exceptions!

- 5. Refund Policy: BEFORE JULY 27<sup>TH</sup> FULL REFUNDS (minus \$5 if paid by credit card)
  AFTER JULY 27<sup>TH</sup> NO REFUNDS
- 6. Rules of Competition Rules of competition will be covered with your child by their coach prior to the season beginning. If you would like a copy of the PYSL Rules of Competition please visit our website <a href="www.pysl.com">www.pysl.com</a> or request one from a board member at the pavilion.
- 7. Protest or Concerns occasionally, something will arise with one of our players or parents have questions or concerns about. Please remember that the only way these can be addressed is in writing. We as a volunteer board take these concerns seriously and will only evaluate them if they are written and signed. Protests are covered very specifically in the rules of competition and our league President Kim Schenk 661 965-6634 or Vice President Jose Osorio 661 941-1363 will be happy to go over and assist you with this procedure.
- 8. Sibling requests to play on same team will be honored so long as age/gender requirements of CALSOUTH are met. Carpool requests will not be considered by the league.
