



PYSL 2023 SPRING SEASON REFUND & PARENT AGREEMENT

Palmdale Youth Soccer League is dedicated to promoting sportsmanship through soccer to the youth of the Antelope Valley. We are a **100% volunteer organization** and to avoid any misunderstandings here are some guidelines.

- Payment of fees does not guarantee your child will be placed on a team.** All players are considered on a first come – first paid basis. Decisions on team sizes and numbers of teams are based upon number of volunteer and what best suits the needs of the majority of the league members. Refund policy is shown below and applies only if your child is placed on a team.
- If your payment is not valid for any reason, your child’s registration will be placed on hold until all funds (including any returned fees) become available. The date the fee is paid in full, is the registration date of your player(s).**
- Your fees include registration, uniform, basic picture package and trophy. Trophies are distributed on the last game of the season to the coaches or team parents.
- Please carefully mark all uniform sizes on the registration form. **Sizes you mark are sizes we order, any mistakes you make will be reordered at cost and charged to you.**

No refunds will be processed without a valid receipt, no exceptions!

Protests are covered very specifically in the rules of competition and our league President Kim Schenk 661 965-6634 or Vice President Leo De Haro 661 495-6393 will be happy to go over and assist you with this procedure.
- Sibling requests to play on same team will be honored so long as age/gender requirements of CALSOUTH are met. **Carpool requests will not be considered by the league.**
- Please keep in mind we are here for the kids; let us all have a great season.

- I acknowledge that once my child is placed on a team, he or she may not be transferred to another team, NO EXCEPTIONS.
- I acknowledge as a parent; all players must participate in the PYSL Fundraiser.
- I acknowledge as a parent; we must participate in helping my child’s team coordinate referee schedules every other weekend and field painting days.
- I acknowledge per LA County Guidelines (Covid-19) players 12+ years must keep proof of Covid-19 vaccination or weekly Covid-19 negative test at every game. Failure to provide proof will result in player being ineligible to play.
